Scanned copies of the following documents are to be up loaded.

1. Bidders should have experience in relevant field of displaying advertisements. Supporting papers to be up loaded,

2. Bidders should also deposit Rs.100000.00 (Rupees One Lakhs) only, as earnest money favouring South Bengal State Transport Corporation, payable at Durgapur. The said amount should be deposited vide the payment link of ICICI Bank provided in the e tender portal. The said amount will be adjusted with the Qtrly. Rental charge of the successful bidder. The said amount will be refunded to the unsuccessful bidder within one month from the date of closing of Tender.

3. The successful bidders should agree to submit a Bank Guarantee which should be equal to the value of the rental charge of a quarter plus GST.

4. Bidders should submit the copy of PAN card, Trade Licence, GSTN documents, Tax returns (e.g. IT, GST etc.) for last three financial years

5. Bidders should give consent for entering into an Agreement with the Corporation regarding the terms and conditions to be imposed later on. Consent letter should be enclosed/uploaded.

6. Bidders should enclose a declaration regarding uninterrupted payment of rental charges as per the Agreement.

7. Bidders should submit a declaration regarding “Not being Black listed/ de listed previously in any organization. Suppression of facts will lead to cancellation of bid/ tender.
